

MINUTES OF THE REGULAR MEETING OF THE EXECUTIVE COMMITTEE OF NEW YORK CITY ECONOMIC DEVELOPMENT CORPORATION December 16, 2020

A regular meeting of the Executive Committee of the Board of Directors of New York City Economic Development Corporation ("NYCEDC") was held electronically, pursuant to notice by an Assistant Secretary, on Wednesday, December 16, 2020.

The following members of the Executive Committee were present by conference telephone:

Mitch Draizin, a Director of NYCEDC, members of the public and members of NYCEDC staff also were present.

The meeting was chaired by Michael Schlein, Chairperson of NYCEDC, and called to order at 9:02 a.m. Meredith Jones, General Counsel, Executive Vice President and Secretary of NYCEDC, served as secretary of the duly constituted meeting, at which a quorum was present.

1. <u>Approval of the Minutes of the November 11, 2020 Regular Meeting of the</u> <u>Executive Committee</u>

There were no questions or comments with respect to the minutes of the November 11, 2020 regular meeting of the Executive Committee, as submitted. A motion to approve such minutes, as submitted, was made, seconded and unanimously adopted.

2. <u>Remarks of the President of NYCEDC</u>

At this time, Mr. Patchett highlighted a few recent announcements and initiatives of NYCEDC. Among other matters, he discussed the plans of Equinor to undertake activities at the South Brooklyn Marine Terminal related to producing off-shore wind energy, which would provide jobs to the Sunset Park neighborhood, NYCEDC's continued efforts with respect to the Pandemic Response Lab at the Alexandria Center for Life Science in Manhattan, and the Mayor's announcement of the City of New York's intention to create a Pandemic Response Institute to build upon the City's experience and set up New York City as the center for industry around pandemic response. Mr. Patchett also noted that NYCEDC had been able to restart over 100 of its capital projects shut down since the onset of the COVID-19 pandemic.

In answer to a question from Mr. Cedeno, Mr. Patchett explained that Equinor agreed to spend \$5 million on local workforce development and training, and that NYCEDC was hoping to create a partnership with a local high school as part of the project. Mr. Patchett further noted on the overall life sciences front that NYCEDC's internship program had grown every year, and that NYCEDC would continue to focus on training, internships and community connection for its projects.

3. Contracts and Other Matters

The following contracts, authorizations, expenditures and matters were then presented to the Executive Committee for approval. (Attached hereto as Attachment 1 is a definition sheet that contains the definitions of certain frequently used terms that may be contained in the Exhibits attached hereto.)

(a) Amendment to NYC Ferry Operating Agreement

James Wong, a Senior Vice President of NYCEDC, presented a proposal (i) for one or more amendments to the operating agreement (the "Operating Agreement") between NYCEDC and HNY Ferry, LLC (the "Operator") for NYC Ferry service, which would increase the funding amount under the Operating Agreement, and (ii) any needed Funding Source Agreements related thereto, on substantially the terms set forth in Exhibit A hereto.

In answer to a question from Mr. Cedeno, Mr. Wong stated that ridership was down significantly in 2020 due to the pandemic. In answer to a question from Mr. Wilkins, Mr. Wong explained that most of the NYC Ferry system was designed to serve the central business districts, but that it also provided access to many other job sites, such as the Brooklyn Army Terminal, the Brooklyn Navy Yard, and the Cornell Tech campus. With respect to the expansion of NYC Ferry, Mr. Wong stated that new proposed routes would be reaching neighborhoods that were poorly served by existing modes of transit. A motion was made to authorize the matters set forth for authorization in the Proposed Resolution section of Exhibit A hereto. Such motion was seconded and unanimously approved.

(b) <u>Queens Emergency Small Business Grant Program</u>

Eric Clement, a Managing Director of NYCEDC, presented a proposal for (i) an agreement with New York City Business Development Corporation ("NYBDC") to provide NYBDC with up to \$15,250,000 in funds for grants of up to \$20,000 each and a fee of approximately 8% of the grant capital administered and any needed ancillary agreements, and (ii) any needed Funding Source Agreements, all for the Queens Emergency Small Business Grant Program, a program to aid small businesses located in Queens that have been impacted by the COVID-19 pandemic, on substantially the terms set forth in Exhibit B hereto. Mr. Clement noted various anticipated criteria for eligibility for grants, including that the grantee could only have up to \$1 million in gross revenue in 2019. He also noted that NYBDC would subcontract work to community partners, to ensure reaching out to diverse businesses and quick distribution of grants.

At this time, Mr. Patchett explained that (1) based on recent feedback and data SBS had shared, NYCEDC planned to raise the \$1 million revenue threshold to as high as a \$3 million threshold, and (2) NYCEDC would also incorporate set-aside funding to help full-service restaurants, given how uniquely they had been impacted by the pandemic.

In answer to a question from Mr. Schlein, Mr. Clement stated that this particular program would involve only grants, but that NYCEDC's plan was to develop a different product in the new year with remaining funds provided by the Steven & Alexandra Cohen Foundation, Inc.. In answer to a second question from Mr. Schlein, Mr. Patchett stated that NYCEDC would like to expand this type of program to all five boroughs if funds became available for such expansion. In answer to a question from Mr. Wilkins, Mr. Clement stated that this program was purely to offer a lifeline to small businesses. In answer to another question from Mr. Schlein, Mr. Clement stated that reporting was a requirement of the contract with NYBDC.

A motion was made to authorize the matters set forth for authorization in the Proposed Resolution section of Exhibit B hereto. Such motion was seconded and approved. Mr. Schlein recused himself from voting on this item because one of the anticipated community partners, Ascendus, was formerly affiliated with Accion.

(c) Modifications to Previous Authorizations – Brooklyn Bridge Esplanade

Kathryn Prybylski, a Vice President of NYCEDC, presented a proposal for (i) an amendment to NYCEDC's contract with Starr Whitehouse Landscape Architects and Planners PLLC for architectural and engineering design and related services for the new Brooklyn Bridge Esplanade adjacent to the East River between Catherine and Peck Slips in Manhattan, to provide for additional project work, including such services for bulkhead rehabilitation work that was being added to the project, and (ii) any needed Funding Source Agreements for this project, on substantially the terms set forth in Exhibit C hereto.

In answer to a question from Mr. Cedeno, Ms. Prybylski stated that the need for the bulkhead work for this project had been determined as a result of the various waterfront inspections performed by NYCEDC's Asset Management Department.

A motion was made to authorize the matters set forth for authorization in the Proposed Resolution section of Exhibit C hereto. Such motion was seconded and unanimously approved.

4. Other Contracts and Matters

The following contracts, authorizations, expenditures and matters were then presented to the Executive Committee for authorization after a brief summary of those matters by James Katz, an Executive Vice President of NYCEDC.

(a) Long Term Recovery Marketing Services

(i) A proposed consultant contract with Shepardson Stern & Kaminsky LLC ("SS&K") for the provision of some or all of branding strategy, creative branding package, production services, and related services and placement of advertisements, including possibly assistance with and making media buys, (ii) a proposed possible consultant contract with a contractor approved by the President of NYCEDC for assistance with and making media buys, (iii) proposed possible contracts for media buys, (iv) proposed media buys, and (v) any needed Funding Source Agreements, all to assist the promotion of life sciences and health innovation and support long term recovery efforts in New York City as New York City recovers from the COVID-19 pandemic, on substantially the terms set forth in Exhibit D hereto. Mr. Katz explained that proposals were sought from contractors in addition to SS&K but that the procurement was still considered to be a sole source procurement under NYCEDC's annual contracts with the City.

(b) <u>Modifications to Previous Authorizations – On-Call General Contractor</u> <u>Services</u>

A proposal with regard to modifying the June 24, 2020 Executive Committee approval for contracts (the "GC Contracts") with three contractors for general repairs, construction and emergency services at various sites owned and/or managed by NYCEDC or designated by NYCEDC for such services, to provide for the substitution of C&B General Construction Corp. ("C&B"), one of the respondents to the project RFP, for one of the originally-approved contractors that withdrew, and thereby to provide that the GC Contracts will be with each of Girandola & Shutkind Construction Corp., Cow-Bay Sprinkler Corp. and C&B, on substantially the terms set forth in Exhibit E hereto.

(c) <u>Modifications to Previous Authorizations – On-Call Rubbish Removal</u> <u>Services</u>

A proposal with regard to a contract with Filco Carting Corp. (the "Filco Contract") for rubbish removal services at various properties owned and/or managed by NYCEDC or designated by NYCEDC for such services, to provide for an extension of the term of the Filco Contract by up to an additional 8 months, bringing the total term of the Filco Contract to up to 50 months, on substantially the terms set forth in Exhibit E hereto.

(d) <u>Modifications to Previous Authorizations – NYC Ferry Homeport 2</u>

A proposal with regard to a contract (the "McLaren Contract") with M.G. McLaren Engineering and Land Surveying, P.C. for marine design and other types of design and engineering and related services for the construction of a second homeport facility for NYC Ferry located in Atlantic Basin, Brooklyn, to (i) provide that funds for the McLaren Contract may be used for any kind of design services, engineering services and related services for the project, (ii) provide up to an additional \$1,250,000 anticipated to be used primarily for design services for fit out and building repairs on the Brooklyn Pier 11 warehouse, which shall house administration and operation services for NYC Ferry, and (iii) provide that the additional funds may also be used for other aspects of the project and previously approved funds may be used for design work related to the Brooklyn Pier 11 warehouse, on substantially the terms set forth in Exhibit E hereto.

(e) Funding Agreements

(i) Proposed funding agreements with (1) Healthview CBWCHC Inc., (2) India Home Inc., and (3) SBH Community Service Network, Inc., or affiliates, and (ii) any needed Funding Source Agreements for said agreements, on substantially the terms set forth in Exhibit F hereto.

Approval of Section 4 Contracts and Matters

A motion was made to authorize the matters set forth for authorization in the Proposed Resolution sections of Exhibits D - F hereto. Such motion was seconded and unanimously approved.

5. <u>Approvals</u>

With respect to the items set forth in Sections 3(a) - (c) and 4(a) - (e) above, it was understood that authorization and approval of such matters included authorization for the President and other empowered officers to execute the necessary legal instruments, and for the President and other empowered officers to take such further actions as are or were necessary, desirable or required, to implement such matters on substantially the terms described above.

6. NYCEDC's 2020 Performance

At this time, Mr. Schlein stated that he felt 2020 had been an incredible and heroic year on the part of NYCEDC's entire staff under the leadership of Mr. Patchett, and that NYCEDC stepped up in ways that few could have imagined, from its work with regard to the production of Personal Protective Equipment to the creation of the Pandemic Response Lab for COVID-19 testing, and so much more. Mr. Schlein then suggested that the Committee adopt a resolution that Mr. Patchett could share with the entire staff. By acclamation the Committee members adopted a resolution that they agreed with Mr. Schlein, with Mr. Patchett abstaining. Mr. Patchett then expressed his thankfulness and appreciation for the amazing team at NYCEDC and the extraordinary work that they had done in 2020. Mr. Schlein also thanked the Board for being nimble and flexible during the past year.

7. Adjournment

There being no further business to come before the meeting, the Executive Committee meeting was adjourned at 9:43 a.m.

Procurement Method: New York Business Development Corporation ("NYBDC") was chosen from 9 potential contractors that NYCEDC contacted based on their experience facilitating grant programs, following a review of their capabilities relevant to this project. Although a competitive process was used, the selection is considered to be a sole source procurement under NYCEDC's annual contracts with the City since a different competitive process was used than specified in the annual contracts. NYBDC is a corporation created under the Banking Law of the State of New York, the purposes of which include providing financial assistance to small businesses unable to obtain financing from private sources and retaining existing businesses in New York State. NYBDC successfully partnered with NYCEDC in 2020 to implement and administer two programs to assist small businesses affected by COVID-19 and in 2012 to implement and administer an emergency program to assist businesses affected by Superstorm Sandy.

Agreements to be Approved:

• An agreement with NYBDC (the "NYBDC Agreement") to provide NYBDC with up

to \$15,250,000 in funds for grants of up to \$20,000 each and a fee of approximately 8% of the grant capital administered and any needed ancillary agreements

Scope of Work: The NYBDC Agreement will enable the use of up to \$15,250,000 for grants under the Program to support small businesses impacted by COVID-19 and related Program expenses.
