NYCEDC reserves the right to commence negotiations with one or more Respondents for the acquisition of the Credits at any time after the first Submission Deadline. RESPONSES ARE DUE NO LATER THAN 11:59 p.m. on dates of the Submission Deadlines.

## **\(\geq\)** EDC

The RFP process will be conducted as follows:

- Respondents may submit Responses on or before each Submission Deadline, and may revise and resubmit their Responses prior to a subsequent Submission Deadline;
- After any Submission Deadline NYCEDC may, at its sole and absolute discretion, elect to close the RFP ("RFP Closing Date"). In the event the RFP Closing Date occurs prior to the final Submission Deadline, Respondents and all parties that have expressed interest in the Credits will be notified via email and a notification will be posted on the NYCEDC website; and
- Should the RFP close, no further Responses will be accepted, and only those Responses received on or before the Closing Date will be reviewed by NYCEDC.
- 2. Section 4.2, RFP Timeline, of the RFP is hereby amended and restated as follows:

Respondents may submit general questions and/or request clarifications from NYCEDC at any time no later than 5:00 p.m. on November 4, 2025. NYCEDC will not answer questions regarding applicability of Credits to Respondents specific permit(s). All such inquiries should be made of the appropriate regulator(s).
