



MINUTES OF THE REGULAR MEETING
OF THE EXECUTIVE COMMITTEE
OF
NEW YORK CITY ECONOMIC DEVELOPMENT CORPORATION
September 28, 2021

A regular meeting of the Executive Committee of the Board of Directors of New York City Economic Development Corporation ("NYCEDC") was held, pursuant to notice by an Assistant Secretary, on Tuesday, September 28, 2021, in Conference Center A/B, at NYCEDC's offices at One Liberty Plaza, New York, New York.

Other Directors of NYCEDC and members of NYCEDC staff also were present.

The meeting was chaired by Danny Meyer, Chairperson of NYCEDC, and called to order at 9:38 a.m. Meredith Jones, General Counsel, Executive Vice President and Secretary of NYCEDC, served as secretary of the duly constituted meeting, at which a quorum was present.

1. Approval of the Minutes of the August 10, 2021 Regular Meeting of the Executive Committee

There were no questions or comments with respect to the minutes of the August 10, 2021 regular meeting of the Executive Committee, as submitted. A motion to approve such minutes, as submitted, was made, seconded and unanimously adopted.

2. Contracts and Other Matters

The following contracts, authorizations, expenditures and matters were then presented to the Executive Committee for approval. (Attached hereto as Attachment 1 is a definition sheet that contains the definitions of certain frequently used terms that may be contained in the Exhibits attached hereto.)

(a) Bronx Museum of the Arts

Zack Aders, an Assistant Vice President of NYCEDC presented a proposal for (i) an agreement and any necessary amendments thereto with Marvel Architects, Landscape Architects, Urban Designers, PLLC to provide design and consulting services, (ii) an agreement and any necessary amendments thereto with a construction manager to provide construction management (“CM”) and related services (including pre-construction, construction and post-construction services), and (iii) any agreements necessary to obtain funds (“Funding Source Agreements”) and any needed amendments to such Funding Source Agreements, all for primarily the demolition of the South Wing Atrium and other portion(s) of the Bronx Museum of the Arts, located at 1040 Grand Concourse, and the design and construction of a new atrium and other portions of the museum building, on substantially the terms set forth in Exhibit A hereto.

In answer to a question from Mr. McSpiritt, Mr. Aders explained that a concept phase would kick off the project, and that such phase would then lead into the actual design for the project. In answer to a second question from Mr. McSpiritt, Mr. Aders stated that the proposed amount for the project took into account the anticipated square footage cost of the anticipated project area. In answer to another question from Mr. McSpiritt, Mr. Aders stated that the selection of the architect was determined with input by NYCEDC, the New York City Department of Cultural Affairs and the Bronx Museum of the Arts. Mr. Aders also explained that there were 49 respondents to the request for proposals (“RFP”) for the design consultant, over 150 questions received, and more than 150 attendees for NYCEDC’s project information sessions.

A motion was made to authorize the matters set forth for authorization in the Proposed Resolution section of Exhibit A hereto. Such motion was seconded and unanimously approved.

(b) Pandemic Response Institute

Melissa Guinan, a Vice President of NYCEDC, presented a proposed contract for no monetary payment with The Trustees of Columbia University in the City of New York (“Operator”) to establish and operate the Pandemic Response Institute (“PRI”), which will be a new component of public health infrastructure dedicated to strengthening the ability of the City of New York (the “City”) to face future health emergencies and epidemics in a more effective and equitable manner and will position the City as a global leader in research, innovation and pandemic response by improving community health and resilience so that New York City is both less vulnerable to future public health emergencies and better prepared to detect, prevent and respond to such emergencies, on substantially the terms set forth in Exhibit B hereto.

In answer to a question from Mr. McSpiritt, Ms. Guinan stated that NYCEDC received 6 responses to the RFP for PRI, and that a number of those were from very competitive, large consortiums of respondents.

A motion was made to authorize the matter set forth for authorization in the

Proposed Resolution section of Exhibit B hereto. Such motion was seconded and unanimously approved.

(c) Modifications to Previous Authorizations – NYC Vaccine Incentive Direct Payments

Jamie Horton, a Vice President of NYCEDC, presented a proposal for (i) an amendment to the agreement with FiCentive, Inc. to provide services related to the New York City Vaccine Incentives Direct Payments Program (the “Incentives Program”), a program to incentivize and increase vaccination among New Yorkers by providing payments to individuals vaccinated at City-run vaccination sites, and (ii) any needed agreements related thereto, to provide additional funds for additional project services, as well as possibly for related project printing and mailing costs, and to provide that payments for the Incentives Program may now be made to certain individuals vaccinated at City-run sites and at certain sites other than City-run sites, on substantially the terms set forth in Exhibit C hereto.

In answer to a question from Mr. Meyer, Mr. Horton stated that this Incentives Program applied only to first doses of the vaccine, and that it did not apply to boosters. In answer to a second question from Mr. Meyer, Ms. Loeb expressed her agreement that it would be an interesting exercise to attempt to calculate the economic benefits to the City derived from the various levers that the City had utilized to increase vaccination against COVID-19, including this Incentives Program.

A motion was then made to authorize the matters set forth for authorization in the Proposed Resolution section of Exhibit C hereto. Such motion was seconded and unanimously approved.

3. Other Contracts and Matters

The following contracts, authorizations, expenditures and matters were then presented to the Executive Committee for authorization after a brief summary of those matters by Fred D’Ascoli, an Executive Vice President of NYCEDC.

(a) Appraisal – Atlantic Center Lease

A proposed amendment to an agreement with KTR Real Estate Advisors LLC for appraisal services related to the lease agreement for Atlantic Center, Brooklyn, dated August 4, 1995, between the City of New York and Atlantic Center Fort Greene Associates, L.P, on substantially the terms set forth in Exhibit D hereto.

(b) Modifications to Previous Authorizations – LifeSci NYC Internship Program

A proposed amendment to the previously authorized contract (the “UWS Contract”) with Upper West Strategies, LLC for services related to the development and

implementation of the LifeSci NYC Internship Program (the “Internship Program”), to provide additional funding for the Internship Program, primarily for costs related to scaling up the Internship Program’s impact and extending the end date of the UWS Contract, on substantially the terms set forth in Exhibit E hereto.

(c) Modifications to Previous Authorizations – Urban Technology Growth Hub

(i) One or more proposed amendments to NYCEDC’s contract with New Lab, LLC (“New Lab”) for the development, launch and operation of the Urban Technology Growth Hub, to provide for additional funds for the project, and to include the provision of additional consulting services whereby, in collaboration with the New York City Department of Transportation (“City DOT”), New Lab will draw from and apply the “Innovation Studio” framework (a proprietary model built by New Lab to research complex challenges, convene stakeholders, build solutions, and pilot innovations) to a bespoke program focused on the theme of improving urban transportation, and (ii) any needed Funding Source Agreements for this project, on substantially the terms set forth in Exhibit E hereto.

(d) Modifications to Previous Authorizations – Manhattan Greenway Harlem River Project

(i) A proposed amendment to the consultant contract with Langan Engineering, Environmental, Surveying, Landscape Architecture and Geology, D.P.C. for engineering, design and construction administration services, and related consultant services, for the design and construction of the Manhattan Greenway Harlem River Project, and (ii) a proposed amendment to a CM contract (a “CM Contract”) with Hunter Roberts Construction Group, L.L.C. (“Hunter Roberts”) to provide for the construction of the Manhattan Greenway Harlem River Project, all to provide for the inclusion of the waterfront and inland areas between 145th Street and 155th Street, also known as the Esplanade Gardens segment of the Manhattan Greenway, in the project, on substantially the terms set forth in Exhibit E hereto.

(e) Modifications to Previous Authorizations – Vincent Avenue Seawall

A proposed amendment to NYCEDC’s 2017 facilities management/construction management contract (an “FM/CM Contract”) with Hunter Roberts (the “2017 Hunter FM/CM Contract”) under which Hunter Roberts provides design, construction and other related work regarding bulkhead rehabilitation of a portion of the Vincent Avenue Seawall, to provide for an increase in the total authorized amount of funding for project work under the 2017 Hunter FM/CM Contract, which increase is the result of required means and methods changes made by the New York State Department of Environmental Conservation for certain project work, on substantially the terms set forth in Exhibit E hereto.

(f) Modifications to Previous Authorizations – Arthur Avenue Market

(i) A proposed amendment to NYCEDC’s CM Contract with Armand Corporation d/b/a Armand of New York to provide additional funds for project work related to the design, construction, CM and other related work to provide upgrades to the basement, plumbing, entrance, and freight elevator at Arthur Avenue Market, on substantially the terms set forth in Exhibit E hereto.

(g) Modifications to Previous Authorizations – Academy Express, L.L.C. (“Academy”) Staten Island Bus Service Contract

A proposed amendment to NYCEDC’s contract (the “Academy Contract”) with Academy for the provision of express bus service between the South Shore of Staten Island and Midtown Manhattan during peak weekday morning and evening hours, as well as for COVID-19 cleaning and disinfecting (until mutually agreed otherwise by Academy and City DOT), to provide for an extension of the term of the Academy Contract, on substantially the terms set forth in Exhibit E hereto.

(h) Modifications to Previous Authorizations – Green Infrastructure Improvements

Proposed modifications to NYCEDC’s contracts with Ove Arup & Partners, P.C., AKRF Engineering, P.C., Hatch Mott MacDonald NY Inc., and Dewberry Engineers Inc. (together, the “Green Contracts”) for civil engineering and related services in connection with green infrastructure improvements at multiple sites across the Newtown Creek combined sewer overflow tributary area in Brooklyn, to provide additional funds for the Green Contracts to provide for an increase in project services including, without limitation, inspection services, on substantially the terms set forth in Exhibit E hereto.

Approval of Section 3 Contracts and Matters

A motion was made to ratify and/or authorize the matters set forth for ratification and/or authorization in the Proposed Resolution sections of Exhibits D – E hereto. Such motion was seconded and unanimously approved.

4. Approvals

With respect to the items set forth in Sections 2(a) – (c) and 3(a) – (h) above, it was understood that authorization and approval of such matters included authorization for the President and other empowered officers to execute the necessary legal instruments, and for the President and other empowered officers to take such further actions as are or were necessary, desirable or required, to implement such matters on substantially the terms described above.

5. Adjournment

There being no further business to come before the meeting, pursuant to a motion made, seconded and unanimously approved the Executive Committee meeting was adjourned at 10:02 a.m.

**BRONX MUSEUM OF THE ARTS
Executive Committee Meeting
September 28, 2021**

Project Description: Primarily the demolition of the South Wing Atrium and other portion(s) of the Bronx Museum of the Arts, located at 1040 Grand Concourse, and the design and construction of a new atrium and other portions of the Museum building, to create a new and more prominent entrance and spacious lobby that is vibrant, welcoming, and amplifies the museum’s ability to engage the surrounding community and enrich the Bronx’s vibrant cultural life.

Borough: Bronx

Type of Contracts: Design contract and CM Contract for the Project.

Amount to be Approved: Up to \$19,430,000 for the Project of which it is anticipated that approximately \$3,000,000 will be used for the Design contract, and all or most of the remaining balance for the CM Contract.

Type of Funds: City Capital Budget funds

Procurement Methods: Publicly advertised RFP for the Design contract; a CM approved by the President or an Executive Vice President selected through a publicly advertised RFP using the competitive sealed proposal procurement method.

Agreements to be Approved:

- An agreement and any necessary amendments thereto with Marvel Architects, Landscape Architects, Urban Designers, PLLC (the “Design Contract”) to provide design and consulting services;
- An agreement and any necessary amendments thereto with a CM (the “Museum CM Contract”) to provide CM and related consulting services (including pre-construction, construction and post-construction services); and
- Any needed Funding Source Agreements or amendments thereto.

Scope of Work: The Project will include demolition of the South Wing Atrium and other portion(s) of the Museum building and related design work, and design and construction work related to building a new atrium and other portions of the building, which work will

re-envision the South Wing Atrium and immediately connecting areas. The improvements will focus on interior spaces to improve circulation, user access and egress, and service access, and increase the overall capacity for occupants and gallery space. The CM will hold all trade contracts and will provide CM services to construct the improvements. It is anticipated that other small consulting contracts, such as for special inspections, that are of a size that does not require Executive Committee approval and existing retainer agreements with available previously authorized funds may also be used for the Project.

Proposed Resolution: To authorize the President and any empowered officer to enter into the Design Contract and the Museum CM Contract, any needed Funding Source Agreements, and any needed amendments to these agreements, substantially as described herein.

PANDEMIC RESPONSE INSTITUTE
Executive Committee Meeting
September 28, 2021

Project Description:

NYCEDC, in partnership with the New York City Department of Health and Mental Hygiene (“DOHMH”), issued an RFP for an operator of the Pandemic Response Institute (“PRI”), which will be a new component of public health infrastructure dedicated to strengthening the City’s ability to face future health emergencies and epidemics in a more effective and equitable manner. The PRI will position the City as a global leader in research, innovation and pandemic response by improving community health and resilience so that New York City is both less vulnerable to future public health emergencies and better prepared to detect, prevent and respond to such emergencies.

NYCEDC will not pay the selected operator for its activities to operate the PRI. However, up to \$20 million of City Capital Budget funds have been allocated for the eligible costs of the physical space and equipment for the PRI, with the scope for use of such funds still under development. Subject to City reviews and approvals, these funds may be provided to the operator by NYCEDC through a funding agreement that would be submitted to the Executive Committee for approval at a later date.

- Integrate racial equity in the structures, operations and interventions of the PRI
