From both of our submission dates [August 26, 2022 and October 21, 2022] for the Offshore Wind Program Proposal Design Sprint, we received 9 (nine) proposals from New York City stakeholders – 4 (four) related to workforce development and 5 (five) to supply chain development—for consideration by OSW developers to place into their NY3 bid. Listed below are brief summaries of the organizations and their proposed program objectives.
