MINUTES OF THE REGULAR MEETING OF THE EXECUTIVE COMMITTEE OF NEW YORK CITY ECONOMIC DEVELOPMENT CORPORATION April 27, 2023

A regular meeting of the Executive Committee of the Board of Directors of New York City Economic Development Corporation ("NYCEDC") was held, pursuant to notice by an Assistant Secretary, on Thursday, April 27, 2023, in Conference Center A/B, on the 14th Floor at the offices of NYCEDC at One Liberty Plaza, New York, New York.

Other Directors of NYCEDC, members of NYCEDC staff and a member of the public also were present.

The meeting was called to order by Margaret Anadu, Chairperson of NYCEDC, at 9:46 a.m. Meredith Jones, General Counsel, Executive Vice President and Secretary of NYCEDC, served as secretary of the duly constituted meeting, at which a quorum was present.

1. <u>Approval of the Minutes of the March 14, 2023 Regular Meeting of the Executive Committee</u>

There were no questions or comments with respect to the minutes of the March 14, 2023 regular meeting of the Executive Committee, as submitted. A motion to approve such minutes, as submitted, was made, seconded and unanimously adopted.

2. Contracts and Other Matters

The following contracts, authorizations, expenditures and matters were then presented to the Executive Committee for approval. (Attached hereto as Attachment 1 is a definition sheet that contains the definitions of certain frequently used terms that may be contained in the Exhibits attached hereto.)

(a) Public Market – Marketing, Programming and Community Engagement

Molly Weilbacher, a Senior Associate of NYCEDC, presented a proposal for a consultant contract with the Lower East Side District Management Association, Inc. ("LESDMA"), and any needed amendments thereto, for LESDMA to provide the services of a full-time community engagement manager at Essex Market, and to provide and oversee programming and marketing activities at Essex Market and graphic design and marketing support services at other public markets managed by NYCEDC, for up to three years (a two-year initial term and one-year renewal option), on substantially the terms set forth in Exhibit A hereto.

In answer to a question from Ms. Anadu, Ms. Weilbacher stated that the contract amount was essentially a rate decided by both parties. She explained that the fee for the proposed contract was based on LESDMA's previous project contract, except that the current proposal incorporated an approximately \$35,000 increase per year from LESDMA's previous contract primarily to cover an increase in insurance and printing costs. In answer to a question from Ms. Velez, Ms. Weilbacher stated that LESDMA was community-based. In answer to another question from Ms. Velez, David Hughes, a Vice President of NYCEDC, explained that minority and women-owned business enterprise ("MWBE") goals were not specifically baked into the contract, but are a strong component of the programmatic services obligated by the contract and LESDMA does a lot of programmatic work that supports low-income families and individuals and nutritional educational capacity building.

A motion was made to authorize the matter set forth for authorization in the Proposed Resolution section of Exhibit A hereto. Such motion was seconded and unanimously approved.

3. Other Contracts and Matters

The following contracts, authorizations, expenditures and matters were then presented to the Executive Committee for authorization after a brief summary of those matters by Josh Kraus, an Executive Vice President of NYCEDC.

(a) On-Call Management and Economic Development Consulting Services: Retainer Contracts

(i) A proposed separate contract with each of Accenture LLP, Bennett Midland, LLC, The Boston Consulting Group, Inc., Buro Happold Consulting Engineers, P.C., Delivery Associates Ltd., Deloitte Consulting LLP, Guidehouse Inc. DBA Guidehouse Consulting, Hatch Associates Consultants, Inc., HR&A Advisors, Inc., Ichor Strategies LLC, and McKinsey & Company, Inc. Washington D.C., or affiliated entities (collectively, the "Retainer Contracts"), and possibly amendments to those Retainer Contracts, to provide for on-call management and economic development consulting services by consultants with experience and expertise in economic research, strategic planning and project management to assist with the furtherance of various City of New York (the

"City") and NYCEDC studies and initiatives, and (ii) any agreements necessary to obtain funds ("Funding Source Agreements") for this project work, on substantially the terms set forth in Exhibit B hereto.

In answer to a question from Mr. McSpiritt, James Golinkoff, a Vice President of NYCEDC, stated that NYCEDC received 27 responses to the request for proposals ("RFP") for these contracts, and that the RFP was not structured for different responses depending on topic area. He explained that, based on similar on-call contracts, NYCEDC felt that the best services were provided by firms that could provide expertise across the 3 project topic areas. In answer to a second question from Mr. McSpiritt, Mr. Golinkoff stated that there were three MWBE respondents to the RFP, and that one MWBE was selected. In answer to a request from Mr. Kimball, Mr. Golinkoff explained that all of the firms were required to subcontract between 30-35% of the project work to MWBEs, and that NYCEDC increased the goal in order to push these firms to subcontract to MWBEs as much as possible.

(b) Station Plaza Business Relocation Services

(i) A proposed agreement and any necessary amendments thereto with Public Works Partners LLC to provide tenant relocation services for the current non-residential tenants located at three lots at 91-20 146th Street, 91-24 146th Street and 90-79 Sutphin Boulevard in Jamaica, Queens that have been acquired by the City and will be used in connection with the development of two pedestrian plazas, which plazas will be part of the Station Plaza project, as well as improvements to pedestrian and vehicular safety in the area, (ii) a proposed amendment to a memorandum of understanding with the New York City Department of Housing Preservation and Development for the Station Plaza project to provide funds for project tenant relocation costs, and (iii) any needed Funding Source Agreements for this project, on substantially the terms set forth in Exhibit C hereto.

(c) <u>Modifications to Previous Authorizations – Full-Service Fire Alarm Maintenance, Repair and Emergency Services</u>

(i) Proposed modifications with regard to a contract with Unisys Electric Inc. ("Unisys") for full-service fire alarm maintenance, repair and emergency services for Bush Terminal and various other sites managed by NYCEDC, to provide additional funds for additional project work, and (ii) any necessary agreements related to this project work, on substantially the terms set forth in Exhibit D hereto.

(d) <u>Modifications to Previous Authorizations – Full-Service Fire</u> <u>Suppression Systems Maintenance, Repair and Emergency Services</u>

(i) Proposed modifications with regard to a contract with Unisys for full-service fire suppression systems maintenance, repair and emergency services at various properties owned and/or managed by NYCEDC, Citywide, including, without limitation, inspection of fire pumps, dry sprinkler systems, wet sprinkler systems, standpipe systems, fire extinguishers, and yard fire hydrants and resulting work, to provide additional funds for

additional project work, and (ii) any necessary agreements related to this project work, on substantially the terms set forth in Exhibit D hereto.

(e) <u>Modifications to Previous Authorizations – Water Street Corridor Streetscape and Plaza Improvements</u>

(i) A proposed amendment to the contract with J. Pizzirusso Landscaping, Corp. for construction services related to the construction of streetscape and plaza improvements for the Water Street corridor, to provide additional funds from utilities to provide for additional construction services for required project utility work, and (iii) any necessary agreements related to this project work, on substantially the terms set forth in Exhibit D hereto.

(f) <u>Modifications to Previous Authorizations – EITC Program: Media</u> Campaign

(i) Proposed modifications with respect to the authorization of a previously authorized consultant contract with each of Athena Consulting Group Inc. ("Athena") and Venus Media Group LLC ("VMG") to provide advertising placement and creative development services to assist the New York City Mayor's Office of Ethnic and Community Media to increase awareness of and participation in the Earned Income Tax Credit program (the "EITC Campaign"), to provide that the EITC Campaign-related services previously authorized by the Executive Committee to be performed (a) under a contract with Athena will be performed under a contract with Veronica Villalpando DBA Athena Consulting of Manhattan (the incorrect name was specified at the previous Executive Committee meeting), and (b) under a contract with VMG will be performed under a contract with Venus Media LLC following the merger of VMG into Venus Media LLC, and (ii) any necessary agreements related to this project work, on substantially the terms set forth in Exhibit D hereto.

(g) <u>Citywide Rehabilitation/Improvements</u>

(i) One or more proposed amendments to NYCEDC's 2017 facilities management/construction management contract with Hunter Roberts Construction Group, L.L.C., to provide for rehabilitation of the bulkhead at the street end of Lipsett Avenue in Staten Island and the portion of the street at the street end, which need rehabilitation due to serious undermining, loss of fill, and collapse of the street end, the scope of which rehabilitation work will include primarily filling and stabilizing all voids and undermining within the shoreline with earthen material and placing large rip rap revetment stones atop the slope and related construction management services, and (ii) any needed Funding Source Agreements related to this project work, on substantially the terms set forth in Exhibit E hereto.

(h) Funding Agreements

(i) Proposed funding agreements with (1) The Carnegie Hall Corporation and (2) Queens Community House, Inc., or affiliates, (ii) a proposed amendment to a funding

agreement with Wildlife Conservation Society, and (iii) any needed Funding Source Agreements for these projects, all on substantially the terms set forth in Exhibit F hereto.

(i) Workforce Development Programs

(i) A proposed agreement with Workforce Development Corporation for services related to the development, administration and implementation of workforce training programs and other workforce development initiatives for fiscal year 2023, and (ii) any needed Funding Source Agreements for this project work, on substantially the terms set forth in Exhibit G hereto.

(j) <u>Modifications to Previous Authorizations – On-Call General Contracting</u> Services

(i) With respect to NYCEDC's contracts with Girandola & Shutkind Construction Corp., Cow-Bay Sprinkler Corp. and C & B General Construction Corp. (collectively, the "GC Contracts") for general contracting services, including, without limitation, repairs, construction, maintenance and emergency services on an on-call basis or pre-described basis, including removal, replacement and/or repairs of various roll down gates and doors, at various properties owned and/or managed by NYCEDC or designated by NYCEDC for such services, Citywide, to provide that the source of funds for all work under the GC Contracts may be, to the extent available for such work, NYCEDC programmatic budget funds, City Tax Levy funds and/or City Capital Budget funds (rather than only NYCEDC programmatic budget funds and, for a previously specified project, City Tax Levy funds), and (ii) any necessary agreements related to such project work, on substantially the terms set forth in Exhibit H hereto.

Approval of Section 3 Contracts and Matters

A motion was made to authorize the matters set forth for authorization in the Proposed Resolution sections of Exhibits B – H hereto. Such motion was seconded and unanimously approved.

4. Approvals

With respect to the items set forth in Sections 2(a) and 3(a) - (j) above, it was understood that authorization and approval of such matters included authorization for the President and other empowered officers to execute the necessary legal instruments, and for the President and other empowered officers to take such further actions as are or were necessary, desirable or required, to implement such matters on substantially the terms described above.

5. Adjournment

There being no further business to come before the meeting, pursuant to a motion made, seconded and unanimously approved the Executive Committee meeting

The Consultant Contracts will have an initial term of three years and NYCEDC will have the option to extend the term for two additional one year extensions at its sole discretion

Scope of Work: NYCEDC proposes to enter into the Consultant Contracts to obtain assistance from consultants with expertise in management and economic development consulting services in order to further various City and NYCEDC studies and initiatives.

It is anticipated that the primary department at NYCEDC for which services will be provided will be Strategy. In overseeing services, it is anticipated that Strategy will collaborate with departments across NYCEDC with relevant expertise to the particular task. As part of their work, the Consultants may also provide assistance to City entities, in which case NYCEDC anticipates that funds would be made available for such work by those entities, and those entities may provide funds to pay NYCEDC for related administrative services.

Pursuant to an RFP that was publicly advertised, NYCEDC selected the Consultants to provide the Project services based upon their expertise and experience in the majority of tasks across the following Topic Areas:

- 1. Topic Area I: Economic Research and Analysis
 - Macroeconomic analysis and labor market analysis
 - Economic modeling
 - Market sizing and segmentation and industry analysis
 - Socioeconomic research and analysis of disparity
 - Data gathering, monitoring and reporting, and program evaluation
- 2. Topic Area II: Strategic Planning
 - Needs assessment and identification of market opportunity
 - Microeconomic, business and financial analysis
 - Option development, strategy and program design
 - Review of best practices
 - Implementation plans
- 3. Topic Area III: Implementation and Project Management
 - Development and implementation of initiatives
 - · General project management

Generally, for each task NYCEDC will solicit a proposal from each of the Consultants chosen pursuant to the Project RFP to provide Project services. On the basis of a review of the proposals, NYCEDC will assign the task to a Consultant. However, for some tasks NYCEDC may need to alter that process and, at the discretion of the President of NYCEDC or his designee, select a Consultant for a Project task on a sole source basis. 



The Stockpile facility at 830 Forbell Street receives clean soil from construction sites, stores it, and makes it available to City and private projects and for community uses such as community and school gardens. Parties dispose of soil without paying a fee to the City or NYCEDC for depositing the soil at the Stockpile and acquire soil without a soil purchase fee. Among its duties, the Consultant will be responsible for determining the eligibility of clean soil offered by generating sites through the review and approval of waste class data and boring logs, manage and separate the various clean soils at the Stockpile, make topsoil for use at City projects, perform soil sampling and analytics in support of receiving sites accepting Stockpile soil, deliver clean soil and topsoil to nearby community gardens, and conduct outreach to City agencies and community stakeholders. New 42 has requested, and NYCEDC proposes to agree, that the Loan repayment schedule be further amended to change the loan repayment commencement date from July 1, 2023 to July 1, 2024 and change the loan maturity date from June 30, 2028 to June 30, 2029. No other changes to the Loan Agreement will be made.
