

MINUTES OF A SPECIAL MEETING OF THE LEGAL AFFAIRS COMMITTEE OF NEW YORK CITY ECONOMIC DEVELOPMENT CORPORATION August 29, 2023

A special meeting of the Legal Affairs Committee (the "Committee") of the Board of Directors of New York City Economic Development Corporation ("NYCEDC") was held, pursuant to notice by an Assistant Secretary, on Tuesday, August 29, 2023, at the offices of NYCEDC at One Liberty Plaza, New York, New York.

The following members of the Committee were present by Zoom:

Members of NYCEDC staff also were present.

The meeting was chaired by Ms. Woo and called to order at 10:08 a.m. Mark Silversmith, a Special Counsel and Assistant Secretary of NYCEDC, served as secretary of the duly constituted meeting, at which a quorum was present.

1. Approval of the Minutes of the February 22, 2023 Legal Affairs Committee Special Meeting

There being no questions or comments with respect to the minutes of the February 22, 2023 special Committee meeting, a motion was made to approve such minutes, as submitted. Such motion was seconded and unanimously approved.

2. Nixon Peabody LLP

At this time, Mr. Silversmith presented a proposal for (i) a legal retainer agreement (the "Retainer Agreement") with Nixon Peabody LLP ("Nixon Peabody") for the provision of legal services to NYCEDC with regard to the refinancing of the developer's or an affiliated entity's (the "Developer's") loan for the Battery Maritime Building Project as outlined in the ground lease between NYCEDC and 10 South Street LLC, as amended and restated, and (ii) any agreements necessary for NYCEDC to obtain funds to pay Nixon Peabody for services under the Retainer Agreement and any other needed agreements related to Nixon Peabody's services under the Retainer

Agreement (together, the "Related Agreements"), on substantially the terms set forth in Exhibit A hereto. Mr. Silversmith stated that the rates and retention of Nixon Peabody for this matter had been approved by the City's Law Department.

In answer to a question from Ms. Woo, Mr. Silversmith confirmed that the costs of the Retainer Agreement would be paid by the Developer.

It was moved that the Committee authorize NYCEDC to enter into the Retainer Agreement and the Related Agreements substantially as described in Exhibit A hereto. The motion was seconded and unanimously approved.

3. Troutman Pepper Hamilton Sanders LLP

Mr. Silversmith then presented a proposal for a legal retainer agreement (the "Troutman Retainer") with Troutman Pepper Hamilton Sanders LLP ("Troutman") for the provision of construction-related legal services, particularly with regard to labor-related issues, for NYCEDC keystone economic development projects, on substantially the terms set forth in Exhibit B hereto. The rates and retention of Troutman for this matter had been approved by the City's Law Department.

At this time, Ms. Woo stated that the rates for Troutman were lower than those for Nixon Peabody because they were rates that the New York City Law Department approved for retainers that were being paid by NYCEDC, and not by a developer as was the case with the Nixon Peabody retainer. In answer to a question from Ms. Woo, Mr. Silversmith stated that the services under this retainer were not project-specific, but rather that they were for various projects for which NYCEDC may require advice on labor and other construction-related issues.

It was moved that the Committee authorize NYCEDC to enter into the Troutman Retainer substantially as described in Exhibit B hereto. The motion was seconded and unanimously approved.

4. Adjournment

There being no further business to come before the meeting, pursuant to a motion made, seconded and unanimously approved the meeting of the Committee was adjourned at 10:13 a.m.

Peabody's services (together, the "Related Agreements")

Scope of Work: Legal services related to the Project, such legal services primarily consisting of (a) services related to termination of documents collateral to the existing loan, including an intercreditor agreement with ACORE, the lender in first lien position, and securing the City's and NYCEDC's ability to seek remedies in the event of the developer's failure to complete the redevelopment of the BMB project, (b) preserving the Historic Tax Credit benefits arising from the project, (c) drafting an/or reviewing estoppel certificates for the Cty, and (d) preserving the City's and NYCEDC's rights under the Lease (including possibly reviewing the Lease to determine if any amendments are needed as a result of the refinancing).

Nixon Peabody will charge the following rates per hour and may be reimbursed for certain out of pocket expenses:
