Mr. Schumer convened the meeting of the Board of NYCNCC at 2:08 p.m., at which time a quorum was present.

### 1. Approval of October 5, 2023 Meeting Minutes

Mr. Schumer brought up the first item for consideration, which was approval of the minutes of the Governing Board meeting held on October 5, 2023. Mr. Schumer asked for a motion to approve the minutes of the October 5, 2023 meeting. The motion was made, seconded, and unanimously approved with no abstentions or recusals.

#### 2. Approval of CY2023 NMTC Allocation Application



Mr. Schumer brought up the next item for consideration which was approval of the CY2023 NMTC Allocation Application. Mr. Schumer provided a very brief overview of the application and NYCNCC staff's plan to submit, explaining that it is consistent with NYCNCC's previous business strategy which has proven successful in past applications and awards. Mr. Schumer also highlighted that NYCNCC has received \$255 million to date.

Ms. Rausch asked if a requested dollar amount is submitted as part of an NMTC allocation application, to which Mr. Schumer stated yes. Ms. Dills elaborated that in this current round, NYCNCC plans to request \$67 million in credits, with the expectation that NYCNCC will likely receive slightly less in allocation amounts based on historic allocations by the CDFI Fund.

There being no additional questions, Mr. Schumer asked for a motion to approve the submission to the CY2023 NMTC Application to the CDFI Fund. The motion was made, seconded, and unanimously approved with no abstentions or recusals.

There being no further business to come before the Board at the meeting, pursuant to a motion made, seconded and unanimously approved, the meeting of the Board was adjourned at 2:13 p.m.
