
Overview



The Vision for Brooklyn Marine Terminal is a generational opportunity to reimagine the site with modern maritime at its core and mixed-uses, including housing and community amenities.








Why is the Economic Development Corporation leading this effort?

Governor Hochul and Mayor Adams worked together to swap NYC's Howland Hook and the Port Authority of NY/NJ's BMT, allowing for a rightsizing of roles and responsibilities between the two agencies.

- Consolidating control with the City will facilitate master planning and new investment
- EDC currently manages numerous major maritime assets including South Brooklyn Marine Terminal, the cruise terminals, 17 NYC Ferry landings and numerous smaller maritime locations
- Allows for development of a city-wide micro-mobility strategy using **EDC** assets




Investment to Date

Under EDC management, the City has already invested over \$160 million in Piers 11 and 12 and has vested interest in resiliency, sustainability, job creation, and modern maritime/mixed use districts.

- The City is spending an additional \$80 million to stabilize and repair Piers 7, 8, and 10, fund a new modern, electrified container crane for operations at the terminal, and fund planning for BMT's future.
- The State has pledged \$15 million towards a future cold storage facility.
- The City has applied for hundreds of millions of dollars in federal funds from the US EPA and the US DOT to help transform BMT into the world's first model for a modern maritime facility optimized for international cargo handling, as well as low-carbon, last-mile freight movement.

A Reimagined Waterfront

A reimagined waterfront can deliver a clean and modern maritime port with a focus on micro-distribution strategies that remove trucks from our streets and increase union working waterfront jobs, as well as provide important community-facing opportunities.







Goals


The Vision for BMT will seek to develop a shared vision for the future of this vital facility and district, centered on the following goals:

- Support a clean and modern maritime port that generates job opportunities and industry growth.
- Reduce emissions by shifting truckbased freight to more sustainable, water-based modes.
- Improve traffic circulation.
- Enhance neighborhood integration.

- Protect the site against increasing threats from climate change.
- Support the long-term financial sustainability of the site.
- Create new mixed-use residential development for the community, and invest in neighborhood opportunities, creation of open space and waterfront access


Since 2002, container activity in the Port of NY&NJ has more than doubled, making it the second largest US port for loaded containers. Container volume is expected to more than double again by 2050.





Red Hook Container Terminal (RHCT) in Brooklyn Marine Terminal handles a very small share (1.4%) of the Port's container traffic and of that, over half (52%) is barged across NY Harbor to New Jersey.




BMT Finger Piers Island National Monument There are 4 finger piers.




