Description of Enforcement Actions and Entities

Number of Ongoing Projects Outstanding

As of September 12, 2024 there were 148 ongoing projects outstanding.

Percentage of Projects Subject to Enforcement Action

The percentage of projects with respect to which enforcement actions are being undertaken (4) as compared to the ongoing projects outstanding (148) is 3%.

Defaulted Projects Not Currently Subject to an Enforcement Action

The number of projects for which events of default under program agreements have taken place and which are not currently subject to enforcement action is 8.

Amounts Recovered by Enforcement Actions

Since the July 11, 2024, Build NYC Resource Corporation Enforcement Action Report, no settlements have been reached or amounts recovered in enforcement actions.

Project Information

Currently, 4 projects are the subject of enforcement action, 8 projects are being closely monitored by the Corporation.
