

# MINUTES OF THE REGULAR MEETING OF THE EXECUTIVE COMMITTEE OF NEW YORK CITY ECONOMIC DEVELOPMENT CORPORATION August 20, 2024

A regular meeting of the Executive Committee (the "Committee") of the Board of Directors of New York City Economic Development Corporation ("NYCEDC") was held, pursuant to notice by an Assistant Secretary, on Tuesday, August 20, 2024, in Conference Center A/B, on the 14<sup>th</sup> Floor at the offices of NYCEDC at One Liberty Plaza, New York, New York.

Mitch Draizin, a Director of NYCEDC, and members of NYCEDC staff also were present.

The meeting was called to order by Margaret Anadu, Chairperson of NYCEDC, at 9:39 a.m. Mark Silversmith, a Special Counsel and Assistant Secretary of NYCEDC, served as secretary of the duly constituted meeting, at which a quorum was present.

1. Approval of the Minutes of the June 18, 2024 Regular Meeting of the Executive Committee

There were no questions or comments with respect to the minutes of the June 18, 2024 regular meeting of the Executive Committee, as submitted. A motion to approve such minutes, as submitted, was made, seconded and unanimously adopted.

#### 2. Contracts and Other Matters

The following contracts, authorizations, expenditures and matters were then presented to the Executive Committee for authorization after a brief summary of those matters by Jeanny Pak, an Executive Vice President of NYCEDC. (Attached hereto as Attachment 1 is a definition sheet that contains the definitions of certain frequently used terms that may be contained in the Exhibits attached hereto.)

#### (a) Hunts Point Food Security Mitigation Project

A proposal for (i) a consultant contract with Henningson, Durham & Richardson, P.C. d/b/a Henningson, Durham & Richardson, Architecture and Engineeering, P.C., and any needed amendments thereto, for design and related services related to undertaking floodproofing measures for the Hunts Point Cooperative Meat Market and the 600 Food Center Drive facility which is part of the Hunts Point Food Center Distribution Center, and (ii) any agreements necessary to obtain funds ("Funding Source Agreements"), and any needed amendments to Funding Source Agreements, for such project work, on substantially the terms set forth in Exhibit A hereto.

#### (b) NYC Marine Highway Program

A proposal for (i) a consultant contract with Matrix New World Engineering, Land Surveying and Landscape Architecture, P.C., and any needed amendments thereto, to provide engineering, design, and environmental review services for the Marine Highway project, which aims to expand economic opportunities by increasing the capacity of NYCEDC-managed docks, piers, wharves and waterfront property for freight transit, thereby supporting NYCEDC objectives of improving transport in the waterways of the City of New York (the "City"), reducing emissions from truck-based transportation, and decreasing wear and tear on the City's roads, and (ii) any needed Funding Source Agreements for such project work, on substantially the terms set forth in Exhibit B hereto.

#### (c) Appraisal Retainer Contracts

A proposal for (i) a consultant contract, and possibly amendments thereto, with each of BBG Inc. d/b/a BBG Valuation, CBRE, Inc., Cogito Realty Partners LLC, Cushman & Wakefield, Inc., Goodman-Marks Associates, Inc., and Max Rosin & Associates, Inc. (collectively, the "Appraisal Contracts") to provide for on-call real estate appraisal, valuation, including financial and market analysis, and related services in connection with real estate sales, leasing, acquisitions, planning, and development activities, and (ii) any Funding Source Agreements necessary to obtain funds for any tasks under the Appraisal Contracts including, without limitation, such agreements with any parties that intend to purchase, lease or develop NYCEDC or City owned or leased real estate or their affiliates, or that plan to reimburse NYCEDC for other services related to urban planning and economic development projects, on substantially the terms set forth in Exhibit C hereto.

#### (d) Chinatown Connections

A proposal for (i) a consultant contract and any necessary amendments thereto with Marvel Architects, Landscape Architects, Urban Designers PLLC ("Marvel") (the "Design Contract"), to provide design and related services for the CC Project (described below), (ii) a construction management ("CM") contract (a "CM Contract") and any necessary amendments thereto with a selected construction manager for the provision of CM and related services (including pre-construction, construction, post-construction and resident engineering services) for the CC Project, (iii) a special inspections contract and any necessary amendments thereto (the "Special Inspections Contract") for the CC Project if a new agreement is being entered into for such services, (iv) a force account agreement and any necessary amendments thereto (the "MTA Agreement") to be entered into with the Metropolitan Transportation Authority (the "MTA") for the MTA to provide project accommodation and related services as a result of CC Project work being undertaken by NYCEDC neighboring MTA facilities, including underground subway tunnels, (v) any needed Funding Source Agreements, and (vi) NYCEDC to make other CC Project expenditures (including possibly payments under an existing special inspections retainer contract) and enter into any other related documents, all in connection with Chinatown Connections (the "CC Project"), a public realm project emerging from the Chinatown Downtown Revitalization Initiative Strategic Investment Plan, which will primarily include (1) a realignment of Chatham/Kimlau Square to improve navigation and expand public space within the complex intersection geometry, and (2) creation of a Chinatown Welcome Gateway to commemorate the cultural heritage of Chinatown, all on substantially the terms set forth in Exhibit D hereto.

In answer to a question from Mr. McSpiritt, Sara Herrera, a Project Manager of NYCEDC, explained that Marvel will have some subcontractors and will lead the project design team and will be in charge of the conceptual, schematic and final designs from an architectural perspective, that Marvel was working closely with Stantec which will be bringing on transportation engineering experts and provide other engineering services to support project site investigations, and that Marvel was a community-based design firm that will also be leading community engagement for the project. Ms. Herrera additionally stated that Marvel was an excellent asset for public realm projects, noting such examples as Marvel's development of the Union Square Visioning Project and leading the design team for the Gansevoort Streetscapes project. It will work closely with some other companies that have experience in the Chinatown community. In answer to a second question from Mr. McSpiritt, Ms. Herrera explained with respect to traffic redesign that the New York City Department of Transportation was working on a traffic study that it would provide to NYCEDC to provide to Marvel, and that aside from the possibility of some slight changes the overall plan was expected to remain the same.

In answer to a question from Mr. Bliss, Jennifer Cass, a Senior Vice President of NYCEDC, stated that NYCEDC did not extensively consider a design-build for this project because NYCEDC was in the midst of re-evaluating its design-build and progressive project delivery structures. Ms. Cass added that because this project was

part of the Public Realm Accelerator portfolio, NYCEDC wanted to send out a public request for proposals ("RFP") for it as soon as possible.

#### (e) <u>Modifications to Previous Authorizations – Elevator Maintenance,</u> <u>Repair and Emergency Services</u>

(i) With respect to a contract with Schindler Elevator Corporation for elevator maintenance, repair and emergency services at properties owned and/or managed by NYCEDC, to provide additional funds for additional project services, and (ii) any necessary agreements related to such project work, on substantially the terms set forth in Exhibit E hereto.

### (f) <u>Modifications to Previous Authorizations – On-Call General Contracting</u> Services

(i) With respect to the contract with Girandola & Shutkind Construction Corp. (the "Girandola Contract") for general contracting services including, without limitation, repairs, construction, maintenance and emergency services on an on-call basis or predescribed basis, including removal, replacement and/or repairs of various roll down gates and doors, at properties owned and/or managed by NYCEDC or designated by NYCEDC for such services Citywide, to provide additional funds for additional project services under the Girandola Contract, and also to correct the project code mentioned in the February 6, 2024 Executive Committee item for modification to the Girandola Contract, and (ii) any necessary agreements related to this project work, on substantially the terms set forth in Exhibit E hereto.

## (g) <u>Modifications to Previous Authorizations – Refrigeration Systems</u> <u>Repairs, Preventative Maintenance and Emergency Services</u>

(i) With respect to the contract with Hughes Environmental Engineering, Inc. d/b/a Hughes Environmental for repairs, preventative maintenance and emergency services on refrigeration systems throughout NYCEDC's asset portfolio, including the Brooklyn Wholesale Meat Market and New Fulton Fish Market, Citywide, to provide additional funds for additional project work, and (ii) any necessary agreements related to such project work, on substantially the terms set forth in Exhibit E hereto.

## (h) <u>Modifications to Previous Authorizations – Brooklyn Cruise Terminal</u> <u>Shore Power Mobile Cable Positioning Device</u>

(i) With regard to a purchase order contract with Watts Marine LLC and a services contract with Watts Marine LLC (the "Watts Services Contract") for the delivery, customization and installation of a mobile cable positioning device ("CPD") at the Brooklyn Cruise Terminal ("BCT") and related work to increase the capability for more ships to plug-in to shore power, to provide additional funds for the Watts Services Contract anticipated to be used primarily for design and engineering services related to a new pier-side shore power plug-in connection point and the relocation of an existing

shore power plug-in connection point at BCT, and (ii) any necessary agreements related to such project work, on substantially the terms set forth in Exhibit E hereto.

## (i) <u>Modifications to Previous Authorizations – Force Account for Manhattan Greenway Harlem River Project</u>

(i) With respect to the force account agreement with the New York City Transit Authority ("NYCTA") to provide subway tunnel inspections and monitoring services during construction of the Manhattan Greenway Harlem River project, to provide additional funds for additional project work, and (ii) any necessary agreements related to such project work, on substantially the terms set forth in Exhibit E hereto.

### (j) <u>Modifications to Previous Authorizations – Station Plaza Intermodal</u> Roadway Improvement Project

(i) With regard to the consultant contract with VHB Engineering, Surveying, Landscape Architecture and Geology, P.C. (the "Design Consultant Contract") for services related to the design and reconstruction of roadway and pedestrian plaza improvements as the Station Plaza Intermodal Roadway Improvement Project (the "SPIRI Project"), to provide (1) that approximately \$2,500,000 of previously authorized funds is being used for the Design Consultant Contract, (2) that NYCEDC no longer intends to enter into a separate resident engineering contract chosen pursuant to an RFP or a construction contract for the SPIRI Project chosen pursuant to an invitation for bids, (3) that the construction for the SPIRI Project will be undertaken through a CM Contract with AECOM USA, Inc., which will perform CM services and supervise subcontractors chosen to undertake SPIRI Project work using procurement methods similar to the procurement methods in NYCEDC's contracts with the City, and (4) that NYCEDC will retain the NYCTA on a sole source basis for approximately \$200,000 for a force account to provide project accommodation and related services for a portion of the SPIRI Project, and (ii) any necessary agreements related to such project work, on substantially the terms set forth in Exhibit E hereto.

## (k) <u>Modifications to Previous Authorizations – On-Call Ferry and Facility</u> <u>Safety, Security and Operations Support Services</u>

(i) A proposed amendment to the consultant contract with Safety Management Systems, LLC (the "SMS Contract") for the provision of on-call ferry and facility safety, security and operations support services for the operation of NYC Ferry, to provide for adjustment to the scope of services under the SMS Contract to include other needed marine and waterfront-related studies related to navigational matters and/or the use of waterways by vessels (including, without limitation, NYC Ferry) or for other uses such as, for example, construction of greenways over waterways, and services for related approvals and regulatory matters, and (ii) any necessary agreements (including Funding Source Agreements) related to such project work, on substantially the terms set forth in Exhibit E hereto.

#### (I) Modifications to Previous Authorizations - Citywide Greenways

(i) With regard to a contract with Sam Schwartz Engineering, D.P.C. (the "Sam Schwartz Contract") for best practices research about the impact and design of the next generation of New York City greenways, and undertaking a citywide opportunity analysis to identify potential future greenway segments, prioritizing the identified segments, and developing feasibility plans for a set of the prioritized segments, to amend the type of funding for the Sam Schwartz Contract such that up to \$1,880,000 will be provided by a US DOT RAISE Grant, and up to \$470,000 will be City Tax Levy funds, NYCEDC programmatic budget funds and/or any other type of funds then available, and (ii) any necessary agreements related to such project work, on substantially the terms set forth in Exhibit E hereto.

## (m) <u>Modifications to Previous Authorizations – LifeSci NYC Internship Program</u>

(i) A proposed amendment to a previously authorized contract with Upper West Strategies, LLC (the "UWS Contract") for services related to the LifeSci NYC Internship Program (the "LifeSci Program"), which connects selected students and recent graduates with career opportunities at life sciences companies and institutions in New York City, may subsidize the compensation of a "host" company's interns to expand the number of opportunities for students and recent graduates, and provides career-building activities and events, to provide additional funds for additional LifeSci Program related services, and also to note that the LifeSci Program in addition to being available to students has been and will continue to be available to recent graduates, and (ii) any necessary agreements related to such LifeSci Program services, on substantially the terms set forth in Exhibit E hereto.

## (n) <u>Modifications to Previous Authorizations – On-Call Transportation</u> <u>Planning and Policy Services</u>

(i) With regard to a contract with each of Arcadis of New York, Inc., STV Incorporated, Hatch Associates Consultants, Inc., WSP USA Inc. and Jacobs Civil Consultants Inc. (collectively, the "On-Call Transportation Contracts") for the provision of on-call transportation planning and policy services, including strategic planning and policy analysis, related to, but not limited to, freight rail, passenger ferries, aviation, maritime and ports, intermodal facilities, traffic and transit, to provide additional funds to provide for additional project services under the On-Call Transportation Contracts, and (ii) any needed Funding Source Agreements related to any tasks under the On-Call Transportation Contracts, on substantially the terms set forth in Exhibit E hereto.

#### Approval of Section 2 Contracts and Matters

A motion was made to authorize and/or ratify the matters set forth for authorization and/or ratification in the Proposed Resolution sections of Exhibits A – E hereto. Such motion was seconded and approved. Mr. O'Sullivan recused himself from voting on the items set forth in Sections 2(a) and 2(n) hereto.

#### 3. **Approvals**

With respect to the items set forth in Sections 2(a) – (n) above, it was understood that authorization, ratification and approval of such matters included authorization for the President and other empowered officers to execute the necessary legal instruments, and for the President and other empowered officers to take such further actions as are or were necessary, desirable or required, to implement such matters on substantially the terms described above.

#### 4. Adjournment

There being no further business to come before the meeting, pursuant to a motion made, seconded and unanimously approved the Executive Committee meeting was adjourned at 9:54 a.m.

#### **Procurement Methods:**

The contractor for the Special Inspections Contract (if a new contract is entered into) and the selected CM will be approved by the President or an Executive Vice President of NYCEDC.

**Scope of Work:** Chinatown Connections is a multifaceted public realm project emerging from the Plan. The Project prioritizes two components of the Plan: (1) realignment of Chatham/Kimlau Square to improve navigation and expand public space within the complex intersection geometry; and (2) creation of a Chinatown Welcome Gateway to commemorate the cultural heritage of Chinatown.

The realignment of the intersection of Chatham Square will reconfigure the streetscape to facilitate east-west and north-south traffic connections; design pedestrian islands, curb extensions and raised crosswalks to shorten pedestrian crossing distances; and incorporate bike lanes to facilitate east-west and north-south connections.

Within Chatham Square lies Kimlau Square, a memorial plaza serving as a pedestrian space. The redesign will expand the plaza at the north side of the intersection and implement a variety of City DOT plaza elements including tinted concrete benches, moveable furniture, plantings, street lighting, wayfinding signage, and utility connections for a future concession kiosk.

A Chinatown Welcome Gateway will be implemented to highlight the neighborhood's cultural heritage. NYCEDC in collaboration with the New York City Department of Cultural Affairs will utilize the Percent for Art Process to select an artist. The artist will form a key part of the design team to define a location, size, shape, and overall design of the Gateway taking into account a City DOT traffic study, existing conditions assessment, and robust community engagement/input.

**Proposed Resolution:** To authorize the President and any empowered officer to enter into the Design Contract, the CM Contract, the Special Inspections Contract, the MTA

Agreement, and any needed Funding Source Agreements, and to make other Project expenditures and enter into other related documents, substantially as described herein.




