## To All Respondents:

This amendment includes an extension of the final Submission Deadline of the NYC Catalyst Fund RFA for respondents proposing debt-focused investment funds.

- For respondents proposing debt-focused investment funds, the final Submission Deadline
  has been extended from April 1, 2025, to September 2, 2025. There will continue to be
  Submission Deadlines on the first business day of each month in between. For the
  avoidance of doubt, the submission deadlines are as follows, all due by 11:59 p.m. ET:
  - April 1, 2025
  - May 1, 2025
  - June 2, 2025
  - July 1, 2025
  - August 1, 2025
  - September 2, 2025
- For respondents proposing debt-focused investment funds, there is an additional deadline for questions on June 13, 2025, with EDC responses posted on/before June 30, 2025
- Respondents to the RFA during this extension period must demonstrate that the Investment Fund, for which they are seeking a Commitment, plans to primarily make private debt investments

## **Amendment Terms:**

1. Section II, "Key Events and Dates" is hereby amended in its entirety to read as follows:

Applicants will be required to submit the materials as outlined in Section VIII "Submission Procedures" and in accordance with the Key Events & Dates described below.

This RFA will be open to all Applicants for a period of 18 months (ending on April 1, 2025), and will remain open for an additional 5 months (ending on September 2, 2025, referred to herein as the "Debt Fund Period") to only those Applicants that manage Investment Funds that primarily



make private debt investments ("Debt Fund Managers"); provided, however, that in either case the RFA will close when all monies are depleted, regardless of the number of months elapsed. Evaluation will be done as an ongoing process as proposals are received.

Deadline for First Round of Questions	October 6, 2023, by 5:00 p.m. ET
