
Today, we are here to receive your comments on the Draft Scope of Work for the Environmental Impact Statement for the **Kingsbridge Armory Development** proposal.

The **Draft Scope of Work** identifies all the subjects that will be analyzed in the upcoming **EIS** and explains how those subjects will be studied.

The purpose of today's scoping meeting is to allow for **public participation** in the preparation of the EIS at the earliest stage possible.

Toward that end, the lead agency will have an opportunity **to receive comments on the Draft Scope of Work** from elected officials, government agencies, community board representatives, and members of the public.

We also welcome **written comments** on the Draft Scope of Work. Written comments can be submitted through **Friday**, **February 28**, **2025 at 5:00p.m.**, to the following email address **ebrunner@cityhall.nyc.gov**



At the end of the written comment period, the lead agency will **review all comments** – those we hear today as well as all written comments we've received.

Comments received will be considered, and incorporated and responded to as appropriate, in the **Final Scope of Work**.

It is the Final Scope of Work that will serve as the basis for preparing the Draft EIS.

Please note that there will be a public hearing for this project after the Draft EIS is issued.



Today's scoping meeting marks the beginning of the **environmental review process** for the **Kingsbridge Armory Development** proposal.

No decisions will be made today regarding the Draft Scope of Work.

The purpose of the meeting is to **allow the public to provide their comments** about the Draft Scope of Work, and to allow the lead agency to **listen to those comments**.

It's important for <u>all voices</u> to be heard today.



I'd like to focus on the structure of today's meeting, which is going to be divided into three (3) parts.

- 1. During the first part, the applicant team will give a **brief overview** describing the proposal, the proposed actions, and the **Draft Scope of Work**.
- 2. During the second part of the meeting, we will be **receiving comments** on the Draft Scope from elected officials, government agencies, and community board representatives.
- 3. During the third and final part of the meeting, the lead agency will **receive comments** from the general public. The meeting will end only when everyone who has signed up to provide testimony has had a chance to be heard.



On to a few logistics **for today's scoping meeting**. The protocol is intended to ensure that **everyone has a chance to speak, and <u>all voices</u> can be heard**.

When it is your turn to speak, your name will be called and you will be allowed to unmute your microphone. Please note that promoting speakers can take some time so we ask that everyone is patient.

Once your name has been called and you have unmuted your microphone, you will be asked to convey your remarks. To allow us to hear from everyone who wishes to speak, we ask you to please limit your remarks to 3 minutes. At the 3:00-minute mark, your time will expire. At that time you will be asked to conclude your remarks. There are a few exceptions to the three-minute time limit. Elected officials, for example, are given the courtesy of jumping to the front of the queue and are not limited to three minutes.

If you choose to turn on your camera, we will be able to see you.

The Kingsbridge Armory

Historic 588,765 GSF military facility in heart of Kingsbridge Heights in the Bronx

Opened in 1917 and used by U.S. military throughout first half of the 20th century

Designated a NYC Landmark in 1974 and listed on New York State and National Register of Historical Places in 1982

One of a few remaining armories in NYC
- transferred to City of New York in 1996

Project site includes lot to the north of the Armory currently used by the New York National Guard












Together for Kingsbridge Community Vision Plan

Together for Kingsbridge is the community's vision for the future redevelopment for the Kingsbridge Armory

Informed by nine months of community and industry feedback gathered at outreach events held between October 2022 and June 2023

In August 2023, the Plan was announced with a \$200 million commitment from the City and State

Rooted in community priorities and drawing on growing industries, the vision plan focuses on creating family-sustaining, local jobs and improving the quality of life for residents of Kingsbridge Heights and neighboring Bronx communities

In September 2023, EDC issued a Request for Proposals (RFP) to solicit proposals for a financially feasible mixed-used development that:

- Delivers at least 25,000 SF of space for community-based organization(s) at a discounted rate



Proposed Land Use Actions

- Disposition of City-owned property (Armory Site and the National Guard Site) to a private developer pursuant to New York City Charter Section 197-c and separate Mayoral and Borough Board approval pursuant to City Charter Section 384(b)(4)
- Acquisition of property from New York State may be required for the redevelopment of the National Guard Site
- A zoning map amendment to rezone the project block to accommodate a wider range of uses, including light industrial
- Zoning special permits may be required to allow an arena capacity of greater than 2,500 persons.

 Additional special permits may be required to allow parking in excess of what is currently permitted
- Zoning text amendments may be required to increase permitted arena capacity, or to modify other requirements. A zoning text amendment may be required to modify minimum distance between buildings on the same zoning lot and maximum base height restrictions.
- If a transit easement volume is required by the MTA, a zoning certification pursuant to ZR Section 66-21



Environmental Review: Framework

An Environmental Impact Statement (EIS) will be prepared to assess the potential impacts of the proposed project

Existing, "No Action," and "With Action" Conditions

- The No Action condition will assume a continuation of existing conditions
- The effects of the proposed project are compared to the No Action

Future Build Year

- 2032
- All elements of the proposed project will be completed.




