
Community feedback is collected at each stage of the planning process, informing the BMT Task Force in their decision-making.

Synthesize feedback in a clear, accessible format to share publicly.



During the two rounds of the workshop presentation, participants deepened their understanding of the different land uses of the site plan, including modern maritime, site circulation, transportation, open space, resiliency, mixed-use/districts, and housing. Each round was followed be a dedicated Q&A period.

Presentation and Q&A Sessions

Project Team lead two rounds of the workshop presentation followed by robust Q&A sessions. Participants strongly requested additional time for these Q&A period. The Project Team extended the duration of both Q&A periods.

- Calls for increasing the amount of affordable housing units included in the site plan and desire to ensure its long-term affordability. Support for funding repairs to the Red Hook Houses.
- Opposition to developing new housing in a flood-prone areas and desire to see increased resiliency for existing residents and neighborhood.
- Request for more details on the transportation and site circulation proposals and their impacts on the surrounding neighborhood.
- Frustration that the planning and engagement timeline feels rushed and request for additional time and opportunities for community engagement prior to the Task Force vote.
- Questions and challenges on how community feedback has been reflected in the site plan and the cross-subsidization financial model.







Interactive Stations and Workshop Boards



Process and Engagement Board

- Confusion about the planning process and how community feedback has been incorporated. Desire for a clear connection between feedback and the proposed plans.
- Frustration that Red Hook has lacked City investment for decades, feeling that current plans do not address existing needs but rather create a new vision not for current users.



Open Space Board

- Dedicating areas in Atlantic Basin for cultural and educational purposes.
- Areas of BMT should be transformed into a year-round destination, akin to Chelsea Piers, with attractions such as retail spaces, restaurants, and event venues.
- Ensure that newly developed open spaces include playgrounds and recreational areas to serve families and children.
- Security concerns surrounding the cruise terminal raised doubts about true waterfront accessibility for the public.
- Desire for visual access to the water, Manhattan skyline, and the Statue of Liberty.
- Community members remain skeptical about the actual delivery of planned green spaces, citing past examples where promised parks were repurposed.
- Proposed greenway should be enhanced and be made pedestrianfriendly given existing traffic congestion. Concern about existing traffic congestion along Van Brunt Street would contradict the plan's commitment to public and community spaces.
- Residents question whether the UPS site acquisition will take place, leading to concerns about public access to the waterfront.


Resilience Board

What we heard

- Ensure **comprehensive resiliency planning** beyond the project site to protect adjacent neighborhoods.
- Address stormwater management and broader environmental concerns.
- Explore adaptive infrastructure that can accommodate worsening climate conditions.
- Questions on how BMT's flood protection initiatives improvements will be integrated with RHCR's efforts and height of proposed flood wall.
- Ensure that housing developments are located in areas with **sufficient** flood mitigation measures. Concern about the BMT South and the suitability for residential development.

Vision for Brooklyn Marine Terminal

Questions about the feasibility of building in a flood plain.



Site Circulation and Transportation Board

- Support for a bus route through the Hugh Carey Tunnel, increasing B61 Service, implementing shuttle service to subway stations, increasing ferry service and adding protected bike lanes.
- Support for transit improvements (bus, ferry) to be implemented now before any new development at BMT.
- Support for truck traffic enforcement and **limiting truck routes** that cut through the neighborhood/cut through the greenway.
- Support for more through streets and/or pedestrian/bike connections **over the BQE Trench**. Support for capping the BQE Trench.
- Limited subway access and insufficient bus service remain critical concerns.
- Concerns on how BMT is being coordinated with DOT BQE Central, and support to be considered holistically.
- Concerns about anticipated increase in traffic congestion due to any **new housing at BMT**. Concerns over increase of for hire vehicles in the area.





Container Port and Flex Terminal Board

What we heard


- Support for investment in modern maritime port that hasn't happened in decades in New York City.
- Support to address traffic before increasing Brooklyn Container
 Terminal (BCT) capacity, through expanding public transit options and improving street management.
- Support for recreational, commercial, cultural uses and entertainment adjacent to Brooklyn Cruise Terminal to draw visitors to Red Hook and promote job growth.
- Questions about when cruise ships and containers ships will fully transition to shore power.
- Questions on the coordination with ConEd regarding any improvements with an electrified port and recommendation to sequence any upgrades.
- Questions on whether a cold storage facility will be included within the port.
- Request for additional clarity and details on Blue Highways at BMT and how it connects to Hunts Point. Some concern on the financial feasibility of Blue Highways.
- Concern about increased truck traffic due to higher container volume, impacting air quality and street safety.




Workshop Board

Key Feedback: BMT North

- Some support for housing, but only if it is 100% affordable.
- Concern on tower-style housing in BMT North due to shadow impacts on open spaces and streets, and that high-rise development will alter visual corridors and increase shade on Columbia Street. Support for lowerheight, contextual buildings that align with the existing neighborhood.
- Concern about the AMI levels, which do not reflect Red Hook's lower-income demographics. Support for deeper level of affordability.
- Preference for local businesses and organizations to occupy commercial and community spaces. Request for indoor open space to foster community and the inclusion of recreation spaces.







Key Feedback: BMT South and Atlantic Basin

- Prioritize access to the water, with more communityfriendly waterfront spaces.
- The new project should engage with the history of the working waterfront (e.g., museum, knowledge center).
- Concerns about transportation challenges with new housing. Concern with the location of the housing at BMT South given the resiliency risks.
- Concerns about shadows from tall buildings impacting open spaces and streets.
- Concern that any new open space will feel unwelcoming or too privatized given the new development.





Written Feedback Boards: Key Theme - Housing


What we heard


Questions about luxury housing on site, desire for deeply affordable housing for low-income residents, concern about building heights and environmental risks. Some opposition to any new housing on the site.


- Recognition that housing is necessary for future generations but must be designed intentionally with a focus on affordability and sustainability.
- Interest in mixed-use development that aligns with existing character of Red Hook neighborhood and integrates residential, commercial, and community spaces as a means of boosting local businesses stabilizing rent prices.
- Need for transportation and infrastructure improvements to support housing development.
- Some opposition to any new housing on site, citing concerns about overcrowding and placing housing in flood-prone areas.

























Written Feedback Boards: Key Theme - Parks and Open Space


What we heard:

- As much open space should be provided as possible.













Written Feedback Boards: Key Theme - Transportation and Infrastructure

What we heard:


Concerns regarding worsening congestion and emissions from trucks and cruise ships and desire to address and mitigate BQE's impact on surrounding community through the Project


- Need sustainable transit solutions that prioritize public health and the environment.
- Bike lanes would improve access to Cobble Hill and nearby areas.
- Need to address potential sewer overflow issue at Valentino Park and integrate this into proposed infrastructure improvements.
- Desire to reduce traffic on Columbia Street and prevent further truck traffic on Union and Sackett Streets.















Written Feedback Boards: Key Theme - Education, Workforce, and Local Business

What we heard:

Interest in youth programs, schools, and community centers to support the growing community, and desire for preservation of maritime space to support working waterfront

- Support for Portside New York to have a permanent home at BMT.
- Desire to activate waterfront with communityoriented and educational uses that serve the public.
- Preference for small-scale retail and support for local businesses.













Written Feedback Boards: Key Theme - Process


What we heard:


Call for more time, transparency, and genuine community engagement with a particular focus on environmental justice as part of the planning process

- Skepticism with financial model and cost assumptions, including the premise that the surrounding community must pay for a project that supports the region.
- Opposition to timeline and emphasis on need for community involvement and input, including the expediated GPP process.
- Concern regarding the number of jobs associated with the port given the cost of the project.
- Need for more environmental justice and impact studies at this stage in planning process.
- Preference for a phased plan with more engagement, specifically with marginalized populations such as senior citizens and NYCHA residents.









