Late submissions will not be accepted. All Submissions must be made electronically through the NYCEDC RFP website at [RFPs | NYCEDC](#) and include the following:

- One PDF File for the Proposal Only “Proposal for Coney Island West Parcel A RFP”
 - Respondents may elect to submit their previous three (3) years of audited financials, Real Property Doing Business Data Form, and Background Investigation Questionnaire in a separate PDF file (and not include such documents in the PDF file for the Proposal above)
- Number of sets of Proposals to be submitted: One (1) electronic copy of all Proposal documents (with the exception of the above documents, if preferred), as stated above, in a zip file labeled with Respondent’s name.

Respondents may elect to provide their previous three (3) years of audited financials, Real Property Doing Business Data Form, and Background Investigation Questionnaire (and not include such documents in any PDF file submitted to the NYCEDC RFP website) by submitting five (5) hard copies in an envelope labeled “Coney Island West Parcel A RFP – [Respondent’s Name]”, which must be submitted to and received by NYCEDC by **no later than 5:00PM ET on May 22, 2025** at:
