Additional Comments

Real Property Acquisition/Disposal: Regarding the reported disposition-lease to Queens Development Group II, LLC, the annual base rent will be \$500,000, beginning on the effective date of the lease and continuing until the earlier of: (a) the completion of stadium construction in accordance with the lease, or (b) the fourth anniversary of the lease effective date (the earlier of (a) and (b), the "Rent Phase-in Date"). Starting on the Rent Phase-in Date, the annual base rent will increase to \$1,000,000, and will escalate to approximately \$4,000,000 annually by the final year of the Initial Term. For the Extension Term, the base rent will be determined based on fair market value, as assessed by an appraiser, taking into account the lease's use restrictions.
